

2018 Nanaimo Fine Art Show – Nanaimo Federation of Canadian Artists



The Federation of Canadian Artists Nanaimo Chapter (hereafter referred to “NFCA”) agrees to accept artwork on consignment in the signature showcase or artwork which was juried into the 2018 Nanaimo Fine Art Show from November 1-4th, 2018.

By signing this document, all parties agree to each stipulation listed in this Agreement:

1. All exhibiting artists must be an Active member in good standing with the Federation of Canadian Artists in Vancouver and be in good standing with one of the following FCA Chapters: Nanaimo, Arrowsmith or Victoria.
2. All exhibited works must be available for sale.
3. If the artists does not deliver the painting that was signed up or juried into the show, then the NFCA will assume it as sold and expect payment of 20% commission from the declared price as payment. No substitute paintings will be accepted for exhibition.
4. The following commission/payment terms will apply to each consigned artwork sold by NFCA unless otherwise expressly stated: 20% commission to NFCA, 80% payment to ARTIST.
5. If ARTIST is required to remit government taxes the ARTIST is responsible for making sure the necessary taxes are remitted on the full purchase amount. The NFCA is not responsible for tax remittances or collection.
6. If a work is purchased by someone during the show that is unable to pickup after the show, artwork will be taken down and given to buyers during the show.
7. ARTIST retains ownership of all work consigned to or represented by the NFCA. ARTIST retains copyright to all consigned artwork in perpetuity, as governed by law.
8. ARTIST agrees that the NFCA may use an image of their art and/or themselves at the event for promotional purposes whether online or in print, for supporting exhibition materials, or for any other NFCA function or future event.
9. ARTIST declares that the work they submit is original and not taken from any source of another’s work and that they hold the copyright to this work or have written permission from the owner of the copyright to use the image in their original art work.
10. By signing this document, you confirm that the artwork submitted and delivered for this exhibition was not completed under the instruction of a teacher/instructor and was not completed as part of a workshop, class, formal education or development course.
11. Payment to ARTIST will be processed within approximately 30 days after receipt of payment from CLIENT to the NFCA.
12. Acceptance of installment payment on a sale will be subject to agreement by ARTIST. Under this agreement ARTIST agrees to accept partial payments as received by the NFCA. Artwork will not be released by the NFCA to CLIENT until full payment is received. Upon ARTIST request, NFCA will provide ARTIST with account statements of sales activity.
13. The NFCA promises to handle all artwork with the upmost care, however the NFCA is not responsible for stolen or damaged paintings if this may occur. If the ARTIST is in need of insurance for their work the ARTIST is responsible for getting this themselves. The paintings are not insured through the NFCA insurance policy
14. Should the consigned artwork remain unsold at the end of show, ARTIST must retrieve their work in a timely manner. The ARTIST is responsible for arranging the collection / return delivery, and also responsible for any associated costs incurred for collection or return delivery. Pickup of paintings is on November 4th between 4:00p.m. to 5:00p.m. - Uncollected works left after 5:00 p.m. are left at the owner’s risk. Contact the show chair Josee Duffhues for related costs and storage charges.
